

CRRSA and ARP Acts

Accountability and Transparency Website Reporting Requirements - July-September 2021

The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA Act) and the American Rescue Plan Act (ARP Act) provides emergency funds for students financially impacted by the COVID-19 pandemic.

The Department of Education encourages institutions to report as soon as possible, but no later than 30 days after the publication of this notice (05/13/21) or 30 days after the date the Department first obligated funds under HEERF I, II, or III to the institution for Emergency Financial Aid Grants to Students, whichever comes later.

Accordingly, the following information must appear in a format and location that is easily accessible to the public. This information must also be updated no later than 10 days after the end of each calendar quarter (September 30, December 31, March 31, and June 30) thereafter, unless the Secretary specifies an alternative method of reporting:

During the quarter, no new method was used to determine Emergency Financial Aid Grants since no funds were distributed. During the Spring 2021 semester, Southeastern Illinois College determined the degree seeking and certificate seeking students enrolled with a current FAFSA at the onset of the semester. Of those students, students receiving Pell received 60% of the \$230,274 CRRSAA funds with non-Pell recipients receiving the remaining 40%. Pell recipients received automatic award of \$505 and non-Pell recipients received automatic awards of \$314 . No funds will be received under the CRRSAA and ARP (a)(4) programs as these are for proprietary schools.
